



## ASSUMPTION OF RISK & INDEMNITY AGREEMENT FOR PAINTBALL

To: Salem Acres Bible Camp (herein referred to as SA) and SA's employees, volunteers, representatives, officers, and agents (herein referred collectively as SA Employees).

Activities at or organized by SA shall include **Paintball** and any other activities and/or related activity that a person participates in or is a spectator of.

"Inherent Risks" of **Paintball** activities shall mean those dangers or conditions that are an integral part of **Paintball**, which include but are not limited to:

1. The failure of equipment [including the Paintball gun, ammunition, protective gear, etc.] in ways that may result in injury, harm, or death to persons around them and/or damage to property in their vicinity.
2. The unpredictability of each participant's reaction to certain hazards such as sticks, stones, insects, sudden movements, unseen or seen objects, persons or unforeseen happenings.
3. The potential of a participant to act in a negligent manner that may contribute to the injury to the participant or others, such as failing to maintain control over the paintball marker or to act within his or her ability.

I, \_\_\_\_\_, hereby sign this agreement on behalf of myself, my child \_\_\_\_\_, personal representatives, my heirs, and assigns, and represent that I have full legal authority to sign this agreement on behalf of my child.

1. In consideration of my child's participation in **Paintball** organized by SA and conducted by SA and/or its employees, I agree to be strictly bound to the terms of this Assumption of Risk and Indemnity Agreement (herein referred to as "This Agreement").
2. I acknowledge that **Paintball** involves Inherent Risks that may cause serious injury to participants.
3. I fully understand the risks and dangers associated with my child's participation in **Paintball** and ACCEPT IT ENTIRELY AT MY OWN RISK.
4. I hereby WAIVE ANY CLAIMS which I or my child may have now or in the future, against SA and SA Employees for injury, death, property damage or any other loss sustained by me or my child as a result of my child's participation in **Paintball**. DUE TO ANY CAUSE WHATSOEVER including, without limitation, negligence on the part of SA and SA Employees. I further AGREE TO INDEMNIFY SA AND SA EMPLOYEES for any and all legal fees (on a solicitor and his client basis) or losses or costs that may be incurred in defending any lawsuit or claim I or my child may bring against them.
5. I appreciate that This Agreement applies whether SA is at fault or not and it limits the liability of SA Employees to the same extent as it limits the liability of SA even though SA Employees are not formal parties to This Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT; I UNDERSTAND THAT THIS DOCUMENT CONTAINS A PROMISE NOT TO SUE SALEM ACRES OR SALEM ACRES EMPLOYEES AND A RELEASE AND INDEMNITY FOR ALL CLAIMS.
